Report on Smarter Balance Assessment

Becky Stanley, Language Arts Coordinator, presented information on the new Smarter Balance Assessment testing. She explained the changes from the MAP testing being done now to the new testing that will be taking effect. Dana Hibbard, Mathematics Coordinator, presented a sample MAP test and asked the Board members to take a practice Smarter Balance Assessment test on their computers so they could see the changes and understand what will be required of students. The schedule for testing begins on April 6 and will continue through mid-May.

Discussion of Civil Engineering Site Evaluations for New Southeast Elementary School

David Bennett of Engineering Surveys and Services presented information on 24 sites his firm has evaluated for a possible location for the new elementary school to be constructed in the southeast portion of Columbia. Ms. Quinley asked that the Board meet in closed session at a later date to discuss contacting landowners and the City of Columbia.
