#### Call to Order

The meeting was called to order by President King at 6:30 p.m.

The first matter of business was consideration of the agenda for the May 13, 2013, meeting of the Board of Education. It was moved by Mr. Whitt that the agenda be approved. The second was by Mr. Sessions. The vote was 7 yes—0 no.

### **Consent Agenda**

The next matter of business was the consideration of the approval of consent agenda items: approval of the minutes of the regular meeting and two executive sessions of the Board of Education held on April 8, 2013; approval of the minutes of the special sessions of the Board of Education held on April 18 and May 2, 2013; approval of the minutes of the executive session of the Board of Education held on May 2, 2013; acceptance of the treasurer's report; approval of bills; approval of personnel recommendations; and approval of business transactions.

The monthly treasurer's report had been previously provided to the Board of Education by Ms. Quinley. The report showed a beginning balance for the month of April in the amount of \$109.42 million, cash receipts of \$11.75 million, cash disbursements of \$16.66 million, and an ending balance of \$104.51 million. The \$104.51 million was invested in government securities in the amount of \$90.32 million and daily investment accounts in the amount of \$14.19 million. The average interest rate for all investments was 0.20%.

The Board of Education had previously been provided a detailed report of bills and expenditures for the month of April 2013. The report totaled 345 pages. The following is a listing and summary of the bills as provided to the Board of Education:

Dr. Rose requested the Home Works memorandum of understanding be removed from the consent agenda and placed under New Business as agenda item 7h. The vote to approve the consent agenda, with the two exceptions noted above, was 7 yes—0 no.

President King thanked Dr. Rose for his two years as Board of Education president and presented him with a plaque in recognition of his dedication.

# **Board President's Report**

Reports from Columbia Missouri National Education Association and Columbia Missouri State Teachers Association Susan McClintic, Columbia Missouri National Education Association president, and Kari Schuster, president of the Columbia Missouri State Teachers Association, presented reports from their respective organizations on recent and future activities.

# Superintendent's Report

#### **Update on Instructional Monitoring (Walkthroughs)**

Dr. Peter Stiepleman, Assistant Superintendent for Elementary Education, and Dr. Jolene Yoakum, Assistant Superintendent for Secondary Education, presented an overview of the ways curriculum monitoring is currently being implemented in the district, including classroom walkthroughs by administrators and district leaders.

#### **Update on Walking School Bus Partnership**

Dr. Belcher updated Board members on the Walking School Bus program, which emphasizes student safety and physical fitness. District administrators are working on forming a partnership with the PedNet Coalition to continue funding the program.

#### 2013-14Budget Update

Dr. Belcher presented an overview of the 2013-14 budget. He discussed recent budget decisions made by the state legislature and the possibility that there could be up to two percent in foundation formula funding for 2013-14, as well as additional state

funding for the Parents As Teachers program. The district also could receive up to \$400,000 in federal funding per year for the next three years since Douglass High School has been named a Title I priority school. Regarding expenditures, kindergarten enrollment numbers have been coming in higher than expected, and there has been an increase in the number of English Language Learners students; thus, there is concern regarding keeping class sizes at a manageable level. A draft of the 2013-14 budget will be presented at the Board's regular meeting on June 10, 2013.

### **New Business**

### **Consideration of Collective Bargaining Agreement**

The collective bargaining agreement negotiated between representatives of the Columbia Missouri National Education Association (CMNEA) and the administrative bargaining team consisting of Dr. Dana Clippard, Andrea Follett, Linda Quinley, and attorney Duane Martin, was presented for consideration. The tentative agreement is the result of ten negotiation sessions held between February 6, 2013, and April 30, 2013. On May 8, 2013, the members of the bargaining unit exclusively represented by CMNEA voted to approve the tentative agreement. It was moved by Mr. Sessions that the contract be approved as presented. The second was by Ms. Mees. After discussion, public comments were received from the following individuals:

After additional discussion, the vote was 7 yes—0 no.

#### Consideration of 2013-14 Teacher Salary Schedule and Issuance of Teacher Contracts

Dr. Dana Clippard, Assistant Superintendent for Human Resources, requested approval to issue teacher contracts for the 2013-14 school year, based on the 2013-14 teacher salary schedule which was just approved as part of the collective bargaining agreement. Dr. Clippard explained that Items 1, 2, and 4 of the recommendations below were included in the agreement; she requested approval of Item 3.

4	During the regular budgeting process and/or as part of an anticipated master agreement, an increase in the compensation rate for district-approved professional development will be recommended effective June 1, 2013. The rate for participants would change from \$15 per hour to \$27 per hour and for presenters from \$21 per hour to \$35 per hour. In preparation for transition and necessary curriculum writing, a recommendation is made that the increased rates for professional development be made effective May 29, 2013, in order to apply a standard rate for like activities. It was moved by Ms. Mees that teacher contracts be issued for the 2013-14 school year as recommended. The second was by Mr. Whitt. After discussion, the vote was 7 yes—0 no.

#### **Consideration of Summer Project Approvals**

Dr. Boren presented an overview of projects planned for summer 2013 in a number of schools, and presented nine bids for approval. It was moved by Mr. Preis that the bids be awarded as recommended. The second was by Mr. Whitt. After discussion and a public comment by Douglass High School teacher Laura Zinszer, the vote was 7 yes—0 no.

#### Consideration of Designation of Lee Elementary School as a Small Autonomous School

Dr. Stiepleman requested, on behalf of the Lee community (parents, teachers, and community members), that the Board authorize a five-year grant for Lee Elementary School to begin operating as a small autonomous school. The school would adhere to all Board policies and would be required to make an annual presentation to the Board. After discussion, it was moved by Mr. Sessions that the grant be authorized as presented. The second was by Mr. Preis. After additional discussion, the vote was 7 yes—0 no.

#### **Consideration of Policies**

Dr. Belcher presented several policy updates and recommendations from the Policy Services division of the Missouri School Boards Association (MSBA). He recommended approval of policies BCE and JO, and that policy ECA be approved for first reading.

- BCE, Board Committees/Advisory Committees to the Board
- ECA, Building and Grounds Security
- JO, Student Records

After discussion, it was moved by Mr. Sessions that policies BCE and JO be approved as presented. The second was by Ms. Wade. The vote was 7 yes—0 no.

Ms. Wade then presented an overview of the proposed revisions to policy ECA. After discussion, it was moved by Mr. Whitt that policy ECA be approved for first reading. The second was by Ms. Mees. After public comments from Marilyn Andre and Alex Barker, the vote was 7 yes—0 no. This policy will be presented for second reading and consideration of approval at the Board's regular meeting on June 10, 2013.

#### **Consideration of School Meal Prices**

Dr. Belcher recommended a 10-cent increase for paid lunches and breakfasts in the district, based on the newest set of regulatory requirements, recent improvements in current food service, and the rising cost of food across the nation. It was moved by Mr. Sessions that the Board of Education approve a 10-cent increase in school lunch prices, resulting in a \$2.60 charge for secondary students, a \$2.35 charge for elementary students, and \$3.10 for adults; and a 10-cent increase to the breakfast price, resulting in a \$1.45 charge for students and \$1.80 for adults. The second was by Mr. Whitt. The vote was 7 yes—0 no.

#### **Consideration of 2012-13 Budget Amendments**

Ms. Quinley presented several proposed amendments to the 2012-13 budget. After discussion, it was moved by Mr. Whitt that the amendments be approved as presented. The second was by Ms. Mees. The vote was 7 yes—0 no.

#### **Home Works Memorandum of Understanding**

Dr. Rose asked for more information about the Home Works memorandum of understanding. After clarification by Dr. Stiepleman, it was moved by Mr. Preis that the memorandum of understanding be approved as presented. The second was by Mr. Sessions. The vote was 7 yes—0 no.

#### **Announcements**

President King announced Mr. Sessions will appear on KFRU on Tuesday, May 14, to review and discuss the May 13 Board of Education meeting.

Board members shared information about various activities in which they have recently taken part or in which they will soon take part.

President King announced there will be no Board of Education work session in May; the next meeting of the Board will be the regular meeting of June 10, 2013.
