Call to Order

The meeting was called to order by President Rose at 6:30 p.m.

The first matter of business was consideration of the agenda for the May 14, 2012, meeting of the Board of Education. It was moved by Ms. Mees that the agenda be approved. The second was by Mr. Whitt. The vote was 6 yes—0 no—1 absent.

Consent Agenda

The Board considered approval of the minutes of the regular session of the Board of Education held on February 13, 2012; the minutes of the special session of the Board of Education held on February 23, 2012; acceptance of the treasurer's report; approval of bills; approval of personnel recommendations; and approval of business transactions.

The monthly treasurer's report had been previously provided to the Board of Education by Ms. Quinley. The report showed a beginning balance for the month of April in the amount of \$97.43 million, cash receipts of \$45.18 million, cash disbursements of \$15.66 million, and an ending balance of \$126.95 million. The \$126.95 million was invested in government securities in the amount of \$110.83 million and daily investment accounts in the amount of \$16.12 million. The average interest rate for all investments was 0.19%.

The Board of Education had previously been provided a detailed report of bills and expenditures for the month of April 2012. The report totaled 244 pages. The following is a listing and summary of the bills as provided to the Board of Education:

Board President's Report

Report from Columbia Missouri State Teachers Association and Columbia Missouri National Education Association Kari Schuster, co-president of the Columbia Missouri State Teachers Association, and Susan McClintic, Columbia Missouri National Education Association president, and presented reports from their respective organizations on recent and future activities.

Resolution for Missouri School Boards Association Vision Project

Ms. Mees presented information about a sample resolution supporting the Missouri School Boards Association Vision Project. The project sets out goals that are similar to those of the Columbia School District's Comprehensive School Improvement Plan (CSIP). After discussion, it was the consensus of the Board that the Columbia Board of Education support the resolution.

(At this point in the meeting, 7:04 p.m., Ms. King arrived.)

Ad Hoc Transportation Committee Update

David Wilson, the district's Transportation Coordinator, presented the Ad Hoc Transportation Committee's recommendations for a three-tier transportation system in the district to replace the current two-tier system effective with the 2012-13 school year. He noted that the district could save up to \$1,343,000 in student transportation expenditures by moving to a three-tier bell schedule, as opposed to increasing spending by approximately \$468,930 by staying with the current two-tier bell schedule. After discussion, the consensus of the Board was that the administration move forward with working on three-tier bus routes, and change the eligibility policy to reflect new ridership eligibility for the 2013-14 school year and beyond (stating that grades K-8 students living within one mile of school are eligible for free bus transportation, and grades 9-12 students living within two miles of school are eligible). A World Café will be held in October 2012 to discuss how this system would work and get input from the public.

Superintendent's Report

Draft 2012-13 Budget

Dr. Belcher and Ms. Quinley presented information on the budget assumptions and parameters used in development of the 2012-13 budget, and reviewed budget additions. Details on 2011-12 projected revenues and expenditures were also provided. The final 2012-13 budget will be delivered to Board members by the end of May and considered for approval at the Board's regular meeting on June 11, 2012.

Summer School Update

Dr. Ian Mette, summer school coordinator, provided a review of programming and enrollment for 2012 summer school. The summer school program, which serves over 7,000 Columbia School District students, will be collaborating this summer with Fun City and Boys and Girls Club, as well as with continuing partners Columbia College, Stephens College, and the University of Missouri.

Secondary Reorganization Update

Dr. Dana Clippard, Director of Human Resources, presented information on the personnel process for secondary reorganization, which is nearly complete with as many assignments made as possible. Assignment letters to teachers will be sent by Friday, May 18, 2012.

New Business

Consideration of Policies

The Board of Education Policy Committee has met and reviewed a number of policy updates and recommendations from the Policy Services division of the Missouri School Boards Association (MSBA). The policies were presented in two groups. Dr. Belcher recommended, on behalf of the Policy Committee and the administration, that the policies in Group A be approved at this time, and that the policies in Group B be approved for first reading.

It was moved by Mr. Sessions that the policies in Group A be approved as presented. The second was by Ms. King. The vote was 7 yes—0 no.

The Board then considered the policies in Group B for first reading. After discussion, it was suggested policy GCBDA, "Professional Staff Short-Term Leaves and Absences," be amended, prior to the second reading of the policy, to include three paid personal days for professional staff; a like amendment will be made to policy GDBDA for support staff. It was moved by Ms. King that the policies in Group B be approved for first reading. The second was by Mr. Sessions. After further discussion and a public comment by Susan McClintic, the vote was 7 yes—0 no. The policies in Group B will be presented for second reading and consideration of approval at the Board's regular meeting on June 11, 2012.

Consideration of 2011-12 Budget Amendments

Ms. Quinley presented several proposed amendments to the 2011-12 budget. After discussion, it was moved by Mr. Whitt that the amendments be approved as presented. The second was by Mr. Sessions. The vote was 7 yes—0 no.

Consideration of School Meal Prices

Dr. Belcher explained that, effective July 1, 2011, Section 205 of the Healthy Hunger-Free Kids Act of 2010 requires Local Education Agencies (LEAs) participating in the National School Lunch Program to provide the same level of support for lunches served to paid students as they are for students eligible for free or reduced-price lunches. The act directs LEAs that currently charge less than a free meal reimbursement rate minus the paid meal reimbursement rate to gradually increase their prices over time until they meet the requirement. Schools may choose to cover the difference in revenue with non-federal funds instead of raising paid meal prices. This provision will help ensure that schools have funding available to support serving nutritious meals. On February 15, 2012, the U.S. Department of Agriculture Food Nutrition Service issued a memo (SP 15-2012) to remind LEAs that for SY 2012-2013, LEAs which, on a weighted average, charged less than \$2.51 for paid lunches in SY 2011-2012 are required to adjust their weighted average lunch price or add non-federal funds to the non-profit food service account. The amount of the per-meal increase will be calculated using 2 percent plus 2.18 percent, or 4.18 percent. Current free lunch reimbursement rates for school year 2011-12 are \$2.77 to \$2.79 per meal and paid reimbursement is 26 to 28 cents, giving a difference of \$2.51. Current charge for paid meals is \$2.15 for an elementary student and \$2.40 for a secondary student, making the weighted average charge \$2.27 per meal. Last year the district raised the paid lunch price by 5 cents, which was a rounded-down figure from the 8 cents the district was required to raise the price in SY 2011-2012. The 3 cents from last year's rounding carries over into this year, causing the new recommendation to be a 9.51-cent increase plus 3 cents. The remaining rollover for school year 2012-13 will be 2.51 cents. The maximum required increase in any given year is 10 cents. It was moved by Mr. Sessions that the 10-cent increase in school meal prices for 2012-13 be approved. The second was by Mr. Cushing. The vote was 7 yes-0 no.

Consideration of Bid for Printing of Professional and Community Education Catalog

It was moved by Mr. Sessions that the bid for printing of the professional and community education catalog for the Columbia Area Career Center be approved. The second was by Ms. King. After discussion and clarification of options by Linda Rawlings, Career Center director, the vote was 7 yes—0 no.

Announcements

President Rose announced Mr. Whitt will appear on KFRU on Tuesday, May 15, to review and discuss the May 14 Board of Education meeting.

Board members shared information about various activities in which they have recently taken part or in which they will soon take part.
