#### Overview

A Long-range Facilities Planning Committee and Finance Committee subcommittee interview team consisted of the following members:

The interview team reviewed proposals from 13 different firms for architectural services. The term of this contract will run through November 30, 2019, with two consecutive one-year periods after the initial contract for consideration of renewal, for a total possible five years. After reviewing all of the proposals, the interview team found the following four firms to be the top four qualified firms and selected them for an interview:

- · Bond Architects, Inc.
- Hollis & Miller Architects
- Ittner Architects
- PWA Architects

Interviews were conducted on September 20 and 21, 2016. After the interviews, the interview team found PWA Architects, in partnership with ACI Boland, to be the best qualified and capable of performing the desired services, and is recommending that this firm be the architect of record for this contract period. This was a mandated qualifications-based selection process, and the criteria for selection were outlined in the request for qualifications. After determining the best qualified firm, the administration began the process of negotiating a final contract, which includes negotiation of a fee schedule. The negotiated contract is attached. The negotiated architect fees of PWA Architects vary depending on project value (see schedule in the attached contract).

# **Fiscal Impact and Funding Source**

The funding for architectural services and for purchase of construction materials will come largely from bond funds or local capital project fund as aligned to each individual project. On occasion, operating funds may be utilized for projects of a non-capital nature.

Estimated fees based on the attached proposal and planned bond issuance, which are not currently engaged, are as indicated below. Additional projects, as approved, will also be engaged under this agreement.
